What is Title IX?

Title IX is a federal law that protects students, employees, faculty, and other members of the University community from all forms of sex discrimination, including gender discrimination, and sexual misconduct. The University of Miami's Title IX office works to prevent, stop, and address sexual misconduct across all campuses and for all community members.

What is sexual misconduct?

Sexual misconduct is an umbrella term that includes: relationship violence (dating, domestic, and/or intimate partner), discrimination, sexual assault/battery, sexual exploitation, sexual harassment, and stalking.

What is sexual harassment?

Sexual harassment refers to unwelcome sexual verbal or physical conduct that is severe, pervasive, and objectively offensive. It can occur between people of the same or different genders or sexual orientations.

What is gender discrimination?

Gender discrimination refers to any discriminatory act committed against another person because of that person's biological sex, gender, or gender expression.

What is sexual assault?

Commonly referred to as rape, sexual assault is defined for University purposes as non-consensual oral, anal, or vaginal penetration or sexual touching (fondling) or intentional contact with the breasts, buttocks, groin, or genitals. Sexual assault also includes incest and statutory rape.

What is consent?

Consent is intelligent, knowing, and voluntary agreement to engage in a specific activity. Intoxication, age, and disability can seriously impair a person's ability to consent.

What about retaliation?

The University prohibits retaliation against anyone who files a complaint of discrimination and anyone who participates in an investigation of that complaint.

What is It's On Us?

It's On Us is a national campaign to end sexual misconduct on college campuses.
